Upon the signature of both parties, you hereby authorize the Professional Photographers of Louisiana, hereinafter known as 'PPLA' to reserve the indicated amount of trade show booth space at – *Southern Pro Xposure 2020*. You, hereinafter known as the 'Vendor' will guarantee that you will accept the booth(s) assigned to you by PPLA.

BOOTH:

Each booth is approximately 8 x 10' and will include a skirted 6' table, two chairs
More than one booth may be purchased and combined to allow for a larger exhibit space.
No exhibit area shall exceed the amount of space requested and paid for by the vendor.

PAYMENT:

If you are a sustaining member of PPLA, the cost of each booth is **\$450 single or \$825 double booth**.
If you are NOT a sustaining member of PPLA, the cost of each booth is **\$600 single or \$1000 double booth**.
To confirm your space, we ask that you return this document with payment of your booth deposit of \$250.

Electrical outlets are an additional \$45 and must be requested in area provided below.
To assure the best placement, final payment of your trade show space is due no later than June 1, 2020.
To confirm your space, we ask that you return this document with payment of your booth deposit of \$250.

ADMISSION: We may be incorporating \$10 Trade Show Entry to be used to purchase anything in the Trade Show, we are still talking about this?

The PPLA trade show is open to all registered attendees of the State Convention. In addition, as a vendor, you have the option of offering 'trade show only' passes to your client base. However, it is at the discretion of PPLA to govern the admission policy for any PPLA event.
